We are committed to reviewing our policy and good practice annually.

The purpose of this policy is;

- To protect children and young people attending Regius School
- To protect staff and volunteers with the overarching principles that guide our approach to safeguarding and child protection

Staff at Regius School believe that a child or young person should never experience abuse of any kind. We have a responsibility to promote the welfare and wellbeing of all children and young people and to keep them safe.

This policy should be read alongside our policies and procedures on:

- Equalities, Administration of Medicine, Attendance, Whistle Blowing and Managing Allegations against staff.

We recognise that:

- The welfare of the child is paramount, as enshrined in The Children (Scotland) Act 1995
- All children, regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity, have a right to equal protection from all types of harm and abuse.
- Some children are additionally vulnerable because of the impact of previous experiences, their level of dependency, communication needs or other issues.
- Working in partnership with children, young people, their parents, carers and other agencies is essential in promoting young people's welfare and wellbeing.

We will seek to keep children and young people safe by:

- Valuing them, listening to them and respecting them
- Appointing a Designated Member of Staff for Safe Guarding and Child Protection for the school
- Adopting the processes and procedures contained within Edinburgh and Lothian's Inter-Agency Child Protection Procedures.
- Developing and implementing an effective e-safety policy and related procedures
- Providing effective management for staff and volunteers through training, support and quality assurance measures
- Recruiting staff and volunteers safely, ensuring all necessary checks are made
- Recording and storing information professionally and securely

- Using our procedures to share concerns and relevant information with agency's who need to know and involving children, young people, parents, families and carers appropriately
- Using our procedures to manage any allegations against staff and volunteers appropriately
- Creating and maintaining an anti-bullying environment and ensuring that we have a policy and procedure to help up deal effectively with any bullying that does arise
- Ensuring that we have effective complaints and whistle blowing measures in place
- Ensuring that we provide a safe physical environment for our children, young people, staff and volunteers, by applying health and safety measures in accordance with the law and regulatory guidance
- Sharing information about safeguarding and good practice with children, their families, staff and volunteers via posters, leaflets, one-to-one discussions
